



## INVITATION TO BID

**CONSTRUCTION OF THREE (3) STOREY MULTI PURPOSE CENTER FOR SOCIAL WELFARE & DEVELOPMENT (STIMULATION THERAPEUTIC ACTIVITY CENTER - STAC, PERSON W/ DISABILITY AFFAIRS OFFICE - PDAO, AND CRISIS INTERVENTION CENTER) AT BARANGAY POBLACION OESTE, DAGUPAN CITY PHASE II**

1. The **City Government of Dagupan**, through **20% DEVELOPMENT FUND CY 2022 CONTINUING** intends to apply the sum of **THIRTY SEVEN MILLION NINE HUNDRED NINETY NINE THOUSAND SIX HUNDRED SEVENTY TWO AND 78/100 PHILIPPINE PESOS (Php 37,999,672.78)** being the Approved Budget for the Contract (ABC) to payment under the contract for procurement of Infrastructure Project, "**CONSTRUCTION OF THREE (3) STOREY MULTI PURPOSE CENTER FOR SOCIAL WELFARE & DEVELOPMENT (STIMULATION THERAPEUTIC ACTIVITY CENTER - STAC, PERSON W/ DISABILITY AFFAIRS OFFICE - PDAO, AND CRISIS INTERVENTION CENTER) AT BARANGAY POBLACION OESTE, DAGUPAN CITY PHASE II**". Bids received in excess of the ABC shall be automatically rejected during the bid opening.
2. The **City Government of Dagupan** now invites bids for the above Procurement Project. Completion of the Works is required within **TWO HUNDRED FORTY (240) CALENDAR DAYS** from the date of receipt of the Notice of Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184.
4. Prospective Bidders may obtain further information from the BAC Secretariat and inspect the Bidding Documents at the address given below during **regular office hours (8:00 A.M. - 5:00 P.M.)**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **September 24, 2024 (8:00 A.M. - 5:00 P.M.) to October 15, 2024 (8:00 A.M. - 12:00 N.N.)** at the given address below during weekdays and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by GPPB, in the amount of **TWENTY FIVE THOUSAND PHILIPPINE PESOS (PHP 25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by providing a printed copy of the official receipt.  
  
The Bidding Documents may also be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)**, provided the Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
6. The City Government of Dagupan will hold a **Pre-bid Conference** on **October 1, 2024, 2:00 P.M.** at **BAC Office, 2<sup>nd</sup> Floor, City Hall Complex, A.B. Fernandez Ave., Dagupan City** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission **on or before 1:00 P.M., October 15, 2024** at **BAC Office, 2<sup>nd</sup> Floor, City Hall Complex, A.B. Fernandez Ave., Dagupan City**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB CLAUSE 15.
9. Bid opening shall be on **October 15, 2024, 2:00 P.M.** at **BAC Office, 2<sup>nd</sup> Floor, City Hall Complex, A.B. Fernandez Ave., Dagupan City**. Bids will be opened in the presence of the bidder's representatives who chose to attend the activity.
10. The City Government of Dagupan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, without thereby incurring any liability to the affected bidder or bidders.
